Mark,

In reviewing the occurrences of last week, there does not appear to be any significant change to the sanitary sewer system from past operations. The large storm events of this year, as well as the saturation from continuous storms, contributed more water than the system could handle. We will continue to work on metering and modeling the system and identifying infiltration sources and possible undersized pipes, so that a long-term solution can be reached. This memo provides more detail into our investigations.

During the storm event last week, GEI worked alongside the City's Public Works Department to identify the reaction of the sanitary sewer system to the storm. Many manholes were investigated to determine flow conditions, and multiple meetings were held last week to discuss occurrences, including system backups in manholes as well as into some basements.

From that meeting, there were a few items that we wanted to investigate immediately. These were how do the flows compare to past years, and what kind of capacity issues were we seeing at the downstream pipes to the wastewater treatment plant. With the help of the Ishpeming Area Joint Wastewater Treatment Facility staff, we were able to gather data both from the storm event, as well as historical events.

We examined historical records for the past 7 years and tabulated any precipitation events over 1". Since 2012, there have been 15 events that fit that description, and 5 of them have occurred in 2018. The two largest precipitation events were both this year, including the most recent one and the one from mid-June. The table below shows the events that were recorded, along with the Daily Flow recorded for the events.

The most recent precipitation event was 3.5 inches in total. It caused peak flows at the plant of approximately 7,000 gpm, for a period of 3 hours. Of that total, based on flow metering data that the facility collects, the City contributed approximately 70% to the peak flow rate observed, or 4,900 gpm. This section of the system was modeled to simulate the storm. Results of the model are shown below:




Figure 1: Modeled Water Levels Near Sanitary Outfall

As can be seen by the red line, the hydraulic grade line (hgl) in the 30" piping does show a surcharged condition from the size storm received. The 24" pipe with wastewater flows from only the City is also impacted by this surcharged condition, and at Manhole WAS-25, approximately 1300 feet down

Washington Street, a surcharge of 3.85 feet is predicted. This matches reasonably well with the highwater lines we saw on the manhole the following day.

One item of concern raised by the City was the contribution of the Negaunee flows to the system, and what effect they had on the flooding. The green line on the figure shows the hgl we would have expected without the contributions of Negaunee flows. As can be seen, there is approximately 0.7 feet of difference between the projected HGL due to Negaunee's flows for this storm, and the HGL if the City of Negaunee had never been connected.

The Blue line on the figure, however, shows the anticipated HGL of the system at the 10.0 MGD flow rate capacity of the system per the agreed to flow allocations. Per an agreement executed by the Ishpeming Wastewater Authority Board Operational Procedures Guide, the City was allocated 4.48 MGD, Ishpeming Township 2.21 MGD, and the City of Negaunee 3.31 MGD. Based upon these numbers and the modeling, one could conclude that the hgl at WAS-25 is about 2.05 ft higher than originally anticipated due to flow rates in excess of 4.48 MGD coming from that portion of the City. As mentioned earlier, it seems that inflow and infiltration into the City's system is more than anticipated.

As discussed, the amount of grit received during the storm was very large, and it may have exacerbated the initial flooding as it moved through the system. However, the data used to model the flows, versus the actual conditions witnessed suggest that the pipes were operating properly, there was just more flow than the system could handle.

We do not believe installing a trash pump at the downstream end of the sanitary system will accomplish much to reduce the hydraulic grade line and upstream surcharging. It is evident from the modeling, that the rate of submergence increases at a higher rate in the 24" sanitary sewers, and if a trash pump could be installed somewhere near WAS-23 or WAS-24, that may relieve the submergence, but in order to do this, the trash pump would need to discharge untreated sanitary sewer into the storm water system and this is not advisable unless approved by the MDEQ.

The main question that has been asked during the events this year, and the system backups, is why now? What has changed? The precipitation recordings show that at the very least, the weather itself has changed significantly. In addition to the large number of events, it is very possible that the additional saturation of the ground is also playing a role in the backups. In the drier years, it was visible that flows at the plant returned to normal more quickly, as dry soils would recover. The saturated conditions this year exacerbate the actual storm events and result in high peak flow rates which results in increased surcharging.

There are some solutions that homeowners may pursue on floor drains to prevent damage from sanitary sewer backups. There are internal check valves that will prevent the drains from backing up into the house. Some communities make these a requirement for customers to install. There are also covers that can be installed on floor drains that can be locked in placed and removed if the floor drains are needed. It is also recommended that homeowner be reminded that sump pumps must not be

connected to the sanitary sewer system. It is recommended that the City consider pursuing some type of inspection program to identify illegal sump pump connections. Some City's make a point to look for illegal sump pump connections while inspecting water meters.

Ishpeming has long had issues with system infiltration, and we are continuing with the SAW grant to work on gathering information. Unfortunately, there doesn't appear to be a quick fix for the problems experienced this year. We need to find the sources of infiltration and eliminate them or reduce them system wide, so that the capacity of the piping is no longer exceeded during storm events. We have recently completed the televising, as well as the manhole inspections. We are beginning our first round of flow metering and will be continuing that effort to obtain infiltration data. We will be building a system model to provide better information on system flows. When all of this is completed, we will have the information needed to guide the City toward resolution to these issues.



Lindberg & Sons quoted us \$6.50 a ton for gravel and \$15 a ton for winter sand. Carlson Loy does not supply gravel and approximately \$11.50 a ton for winter sand. Moyle did not respond to our request for quotes. We would like to purchase 800 ton of gravel from A. Lindberg & Sons and 1100 ton of winter sand from Carlson Loy. The totals cost for each would be approximately \$5200 for gravel and \$12650 for winter sand.
