## CITY ATTORNEY INTERVIEW - CAROLINE BRIDGES

A motion was made by Councilmember Scanlon and supported by Councilmember Bean to execute the 5-year lease agreement with Core and Main as presented. Ayes: Mayor Mike Tonkin, Councilmembers Lindsay Bean, Jason Chapman, and Pat Scanlon (4). Nays: Councilmember Stuart Skauge (1). Motion passed 4-1.

Council discussed the interview with applicant Caroline Bridges. Manager Cugini reviewed the score sheets provided by Council. Mayor Tonkin expressed concerns with some issues he uncovered during his research of the applicant.

A motion was made by Councilmember Scanlon, supported by Councilmember Chapman to direct the City Manager to execute a contract with Caroline Bridges for attorney services for one year. Ayes: Councilmembers Lindsay Bean, Jason Chapman, Pat Scanlon, and Stuart Skauge (4). Nays: Mayor Mike Tonkin (1). Motion passed 4-1.
