# FINANCIAL REPORT

Bob Hendrickson, Greater Ishpeming Negaunee Chamber of Commerce Director, provided a brief update. The Chamber has had several new members join.

Ladies Night Out went extremely well. And November 22, 2021 was Small Business Appreciation night.

Mr. Hendrickson also presented the Chamber's Financial Report stating that the fund balance was at \$27,572.00.

Member Magnuson also reported that port-a-potties have been rented and made available until December 23, 2021 near Santa's House.

## **OLD BUSINESS**

Manager Cugini gave an update on the iron ore carts. They have been received and have been placed on rails around Lake Bancroft.

Member Aeh questioned the status of the Mather Inn. Manager Cugini stated that he was not aware of any changes. Member Clancy assured the members that even though it has not been winterized, as of yet, he would make sure that it didn't freeze.

## **NEW BUSINESS**

Member Aeh announced that the West End Bike & Ski is now officially open for business.

The Anderson building has been put up for sale by Moyle. The building has been stabilized and a new roof was put on.

Interest has been shown in turning the old Symon's building into a multi-event center.

Manager Cugini informed Members that the City has applied for a grant through the EPA that would support a 4-6-month study that would analyze local outdoor recreation and how it would affect the downtown area.
