Revenues for the Sewer Fund came in just shy of \$156k. Major expenditures driving the large decrease in fund balance month over month are a product of a reallocation of CWSRF project engineering and bond issuance costs from the Sewer Project Fund which is no longer being used. Although funding has been approved, no monies relating to the bond or grant have been received, hence the sharp decrease to ending fund balance for September. Additionally the Sewer Fund paid \$110k for slip lining performed which goes towards satisfying the non-participating cost requirements for the Category B funding the City is pursuing. Lastly, \$51k for treatment costs covering the October 2023 period were paid in September.

ORDINANCE NO. 11-2600

CITY OF ISHPEMING PARKS AND RECREATION COMMISSION ORDINANCE

THE CITY OF ISHPEMING ORDAINS:

<u>Section 11-2601</u>. There is hereby created a Parks and Recreation Commission in the City of Ishpeming.

Section 11-2602. The Parks and Recreation Commission shall consist of Seven (7) members. Six members shall be appointed by the Mayor with approval of the City Council, including one member who shall be a member of the City Council. The seventh member shall be appointed by the Ishpeming Public School Board. Each member shall be a resident of the City of Ishpeming. The member appointed to represent the Ishpeming Schools who may or may not be a resident of the City of Ishpeming.

Section 11-2603. The term of office of each Commission member, other than the School member and the City Council member, shall be three (3) years or until their successor is appointed. The School member shall serve at the pleasure of the Ishpeming Public Schools Board. The City Council member shall serve until his or her term on the City Council expires. The Parks and Recreation Commission members currently serving at the time of adoption of this Ordinance shall continue to hold their positions until the expiration of the term for which each was originally appointed.

<u>Section 11-2604</u>. The Parks and Recreation Commission shall meet at least every other month (6 meetings per year). A quorum for the conduct of business shall be four (4) members. The Commission shall adopt a set of By-laws for its operation.

<u>Section 11-2605</u>. The Commission shall be considered a Public Body under the Michigan Open Meetings Act and shall conduct business at open, public meetings.

<u>Section 11-2606</u>. The Parks and Recreation Commission is created for the purpose of advising the City Council and the City Manager regarding the planning, operations and maintenance of all Park and Recreation areas and facilities within the City which may include, but is not limited to, the following:

- (1) To make recommendations to the City Council for the creation and implementation of plans for the establishment, development, re-development and maintenance of current and future parks and recreational facilities;
- (2) To recommend to the City Council policies, rules and regulations, and fees as necessary or desirable with respect to the use of public park, recreation and athletic facilities;

(3) To supervise, oversee and coordinate the use and operation of public park, recreational and athletic facilities, and to schedule the use thereof.

Section 11-2607. This Ordinance shall be effective upon publication.

CITY OF ISHPEMING Resolution 16 - 2023 Establishing Early Voting Location

WHEREAS, the voters in Michigan on November 8, 2022, approved the passage of Proposal 22-2, which in part, entitles voters the right, once registered, to vote in each statewide and Federal election in person at an early voting site prior to election day, open for nine (9) consecutive days beginning on the second Saturday before the election and ending on the Sunday before the election, for at least eight hours each day; and

WHEREAS, the City of Ishpeming's Early Voting Precinct for State and Federal Elections will be open for nine (9) consecutive days beginning the second Saturday before election day through the Sunday before election day during the hours of 10:00 a.m. to 6:00 p.m.; and

WHEREAS, the Early Voting Precinct may also be utilized, operating with different hours as may be set by the Clerk, for local and countywide elections; and

WHEREAS, the City of Ishpeming will enter into an Early Voting Site Agreement with Marquette County and it has been determined that the Negaunee Township Community Center located at 42 M-35 in Negaunee meets all polling location requirements established by state law, and will be the Early Voting Precinct for all registered voters in the City of Ishpeming; and

WHEREAS, all Early Voting dates and times will be posted sufficiently forty-five (45) days prior to every election to notify voters;

NOW THEREFORE BE IT RESOLVED, that the Ishpeming City Council, in accordance with MCL 168.662, hereby approves the establishment of the Negaunee Township Community Center located at 42 M-35 in Negaunee, as a City of Ishpeming polling location, and the Early Voting Precinct for the City of Ishpeming's registered voters.

CITY OF ISHPEMING RESOLUTION 17-2023

STATE DISASTER CONTINGENCY FUND GRANT RESOLUTION

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ISHPEMING,

WHEREAS, the City of Ishpeming, Michigan, is a political subdivision within the State of Michigan with an official Emergency Operations Plan in compliance with Section 19 of the Emergency Management Act, Act 390, Public Acts of 1976, as amended.

WHEREAS, the City of Ishpeming, sustained severe losses of major proportions brought on by a snow event followed by rapid melt occurring between April 30 and May 5, 2023. The resulting conditions included the already saturated ground (ground water table) significantly increased the ground water infiltration into the city sanitary sewer and stormwater infrastructure. Subsequently flooding of many low-lying areas occurred throughout town. The most extensive damage was to the 7-foot concrete storm pipe located at the Partridge Creek outflow. This damage has contributed to a depression having formed, washing the gradient base materials along with the restricted flow (carrying capacity of the system – no known total blockage).

WHEREAS, the Ishpeming City Council certifies that the County Emergency Operations Plan was implemented at the onset of the disaster on the morning of May 1, 2023 and all applicable disaster relief forces identified therein were exhausted.

WHEREAS, as a direct result of the disaster, public damage and expenditures were extraordinary and place an unreasonably great financial burden on the City of Ishpeming totaling more than \$250,000.

NOW THEREFORE BE IT RESOLVED THAT the Ishpeming City Council requests the Governor authorize a grant to the City of Ishpeming from the State Disaster Contingency Fund pursuant to Section 19, Act 390, Public Acts of 1976, as amended.

FURTHERMORE, Craig H. Cugini, is authorized to execute for and in behalf of the City of Ishpeming the application for financial assistance and to provide to the State any information required for that purpose.

Dear Mr. Cugini:

We have reviewed the above referenced door repair work at City Hall on September 13, 2023, along with the two (2) competitive quotes the City received, and offer the following:

- 1. We confirm that the existing door, transom, door frame and non-load bearing wall surrounding the door need to be replaced.
- 2. We requested "The Window Store" adjust their quote to add in a few needed items to be comparable "apples to apples" with the other quote from "Stonehouse Window and Door".
- 3. After reviewing the two (2) on an "apples to apples" basis:

The Window Store quote = \$7,817.00*

Stonehouse Window & Door quote = \$9,843.55

*The Window Store does not have finish painting in their quote, which is an approximate \$400 to \$500 value.

Based on the above information, we recommend accepting the 9/19/23 quote from "The Window Store" for \$7,817.00 to replace the existing employee entrance door and surrounding wall and framing. (Even with an additional \$500 for finish painting, The Window Store's quote is almost 20% less than the other quote.)

The Planning Commission conducted 2 Public Hearings on October 02, 2023 affecting the Zoning Map and the Zoning Ordinance as follows:

Re: Ishpeming Planning Commission's Recommendations from October 02, 2023 Public Hearings:

(A) RZ 2023-02 Rezoning from GC (General Commercial) to MR (Multiple Residential)

This was determined to be a mapping error carried over from the 1984 Zoning Map to the current 2017 Zoning Map.

The Planning Commission recommends to the Council that Lots 56, 57, & 58 of U.S. Steel Corporation Assessor's Plat No. 1 of the Hard Ore Extension be rezoned from the GC (General Commercial) Zoning District to the MR (Multiple Residential) Zoning District.

(B) ZTA 2023-01 Zoning Ordinance Text Amendments

The Planning Commission recommends to the Council to remove the strikethrough text and replace it with the **bolded** Zoning Ordinance text amendments:

Section 15.3 A to amend parking requirements to require ... Two (2) One (1) Off-Street Parking Space Per Unit and to add to Section 15.4 Conditional Uses Item I:

I. Owner or rental residentially occupied units located on the First Floor which must have One (1) Off-Street Parking Space Per Unit.

These revisions are anticipated to result in increased development flexibility and opportunities in the CBD (Central Business District).



ORDINANCE NO. 11-2700

TAX EXEMPTION ORDINANCE

	
	An Ordinance to provide for a service charge in lieu of taxes for a housing project for
low	income persons and families to be financed with a federally-aided Mortgage Loan pursuant to

the provisions of the State Housing Development Authority Act of 1966 (1966 PA 346, as amended; MCL 125.1401, et seq) (the "Act").

THE CITY OF ISHPEMING ORDAINS:

SECTION 1. This Ordinance shall be known and cited as the City of Ishpeming Tax Exemption Ordinance No. 11-2700 – Anderson Lofts and Peninsula Lofts

SECTION 2. Preamble.

ADOPTED:

It is acknowledged that it is a proper public purpose of the State of Michigan and its political subdivisions to provide housing for its low income persons and families and to encourage the development of such housing by providing for a service charge in lieu of property taxes in accordance with the Act. The City of Ishpeming is authorized by this Act to establish or change the service charge to be paid in lieu of taxes by any or all classes of housing exempt from taxation under this Act at any amount it chooses, not to exceed the taxes that would be paid but for this Act. It is further acknowledged that such housing for low income persons and families is a public necessity, and as the City of Ishpeming will be benefited and improved by such housing, the encouragement of the same by providing real estate tax exemption for such housing is a valid public purpose. It is further acknowledged that the continuance of the provisions of this Ordinance for tax exemption and the service charge in lieu of all *ad valorem* taxes during the period contemplated in this Ordinance are essential to the determination of economic feasibility of the housing projects that is constructed or rehabilitated with financing extended in reliance on such tax exemption.

The City of Ishpeming acknowledges that the Sponsor (as defined below) has offered, subject to receipt of an allocation under the LIHTC Program by the Michigan State Housing Development Authority, to acquire, rehabilitate, own and operate a housing project identified as Anderson Lofts and Peninsula Lofts on certain property located at 100 S Main, 105 S Main St, 203 S Main St, 114 W Pearl St and 112 E Pearl St (further described in Exhibit A) in the City of Ishpeming to serve low income persons and families, and that the Sponsor has offered to pay the City on account of this housing project an annual service charge for public services in lie u of all *ad valorem* property taxes.

SECTION 3. <u>Definitions.</u>

- A. Authority means the Michigan State Housing Development Authority.
- B. <u>Annual Shelter Rent</u> means the total collections during an agreed annual period from or paid on behalf of all occupants of a housing project representing rent or occupancy charges, exclusive of Utilities.
- C. <u>LIHTC Program</u> means the Low Income Housing Tax Credit program administered by the Authority under Section 42 of the Internal Revenue Code of 1986, as amended.
- D. <u>Low Income Persons and Families</u> means persons and families eligible to move into a housing project.
- E. Mortgage Loan means a loan that is Federally-Aided (as defined in Section 11 of the Act) or a loan or grant made or to be made by the Authority to the Sponsor for the construction, rehabilitation, acquisition and/or permanent financing of a housing project, and secured by a mortgage on the housing project.
- F. <u>Sponsor</u> means CHN Anderson Peninsula Limited Dividend Housing Association Limited Partnership and any entity that receives or assumes a Mortgage Loan.
- G. <u>Utilities</u> means charges for gas, electric, water, sanitary sewer and other utilities furnished to the occupants that are paid by the housing project.

SECTION 4. Class of Housing Projects.

It is determined that the class of housing projects to which the tax exemption shall apply and for which a service charge shall be paid in lieu of such taxes shall be housing projects for Low Income Persons and Families that are financed with a Mortgage Loan. It is further determined that Anderson Lofts and Peninsula Lofts is of this class.

SECTION 5. Establishment of Annual Service Charge.

The housing project identified as Anderson Lofts and Peninsula Lofts and the property on which it will be located shall be exempt from all *ad valorem* property taxes from and after the commencement of construction or rehabilitation. The City acknowledges that the Sponsor and the Authority have established the economic feasibility of the housing project in reliance upon the enactment and continuing effect of this Ordinance, and the qualification of the housing project for exemption from all *ad valorem* property taxes and a payment in lieu of taxes as established in this Ordinance. Therefore, in consideration of the Sponsor's offer to construct/rehabilitate Anderson Lofts and Peninsula Lofts and operate the housing project, the City agrees to accept payment of an annual service charge for public services in lieu of all *ad valorem* property taxes. Subject to receipt of a Mortgage Loan, the annual service charge shall be equal to 4% of the Annual Shelter Rents actually collected by the housing project during each operating year, exclusive of charges for gas, electric,

water, sanitary sewer, and other utilities furnished to the occupants that are paid by the housing project.

SECTION 6. Contractual Effect of Ordinance.

Notwithstanding the provisions of section 15(a)(5) of the Act to the contrary, a contract between the City and the Sponsor with the Authority as third party beneficiary under the contract, to provide tax exemption and accept payments in lieu of taxes, as previously described, is effectuated by enactment of this Ordinance.

SECTION 7. Limitation on the Payment of Annual Service Charge.

Notwithstanding Section 5, the service charge to be paid each year in lieu of taxes for the part of the housing project that is tax exempt but which is occupied by other than low income persons or families shall be equal to the full amount of the taxes which would be paid on that portion of the housing project if the housing project were not tax exempt.

SECTION 8. Payment of Service Charge.

The annual service charge in lieu of taxes as determined under this Ordinance shall be payable in the same manner as general property taxes are payable to the City and distributed to the several units levying the general property tax in the same proportion as prevailed with the general property tax in the previous calendar year, except that the annual service charge shall be paid in one (1) annual payment, which annual payment shall be paid to the City on or before May 1 of each year for the previous calendar year. Collection procedures shall be in accordance with the provisions of the General Property Tax Act (1893 PA 206, as amended; MCL 211.1, et seq).

SECTION 9. Duration.

This Ordinance shall remain in effect and shall not terminate so long as a Mortgage Loan remains outstanding and unpaid, the housing project remains subject to income and rent restrictions under the LIHTC Program, or a land use restriction for affordable housing remains on the property; provided that construction of the Housing Development identified as Anderson Lofts and Peninsula Lofts commences within three years from the effective date of this Ordinance; and provided further that in no event shall the exemption granted under Section 5 of this Ordinance continue for more than 30 years. In the event that Anderson Lofts and Peninsula Lofts fails to meet the requirements in this section, then this Ordinance may be amended in the sole discretion of the Ishpeming City Council.

SECTION 10. Severability.

The various sections and provisions of this Ordinance shall be deemed to be severable, and should any section or provision of this Ordinance be declared by any court of competent jurisdiction to be unconstitutional or invalid the same shall not affect the validity of this Ordinance as a whole or any section or provision of this Ordinance, other than the section or provision so declared to be unconstitutional or invalid.

SECTION	11.	Inconsistent	Ordinances

All ordinances or parts of ordinances inconsistent or in conflict with the provisions of this Ordinance are repealed to the extent of such inconsistency or conflict. [this section is required]
