VII. Parking Control.

- 1. Anything to the contrary notwithstanding in any City Ordinance or upon any other traffic control order, no person shall park a vehicle upon any street in the City of Ishpeming so as to reduce the width of the traveled portion of the street to less than twelve (12') feet.
- 2. Only buses shall park upon the following designated area:
- a. Pine Street, west side, between the entrance to the north City parking lot and the entrance to the south City parking lot adjacent to the Senior Citizens Center.
- 3. A loading zone is designated in front of the main entrance of the Gossard Building on Cleveland Avenue.
