# Ishpeming Downtown Development Authority Minutes Manday System Au 28, 2015

Monday, September 28, 2015

The regular meeting of the Ishpeming Downtown Development Authority was held on Monday, September 28, 2015 in the Ray Leverton Room at the Carnegie Public Library. The meeting was called to order by David Aeh at 4:00 p.m.

## **APPROVAL OF MINUTES**

A motion was made by Mrs. Arsenault, supported by Mrs. Demarest and carried unanimously to approve the August 24, 2015 minutes as presented.

## **FINANCIAL REPORT**

Jim Lampman reviewed the financial report for the period ending August 31, 2015 which included summarizing the revenues and expenses for the month. A motion was made by Mrs. Gauthier, supported by Mr. Clancey and carried unanimously to approve the financial reports as presented.

## BEAUTIFICATION COMMITTEE

Linda Andriacchi illustrated the "labor saver liner" self-watering planter she would like to purchase for 2016. She felt this would help with the watering problems that occurred this year along with potentially less time involved in watering. The cost for the basket liners were approximately \$25 for the small and \$93 for the large.

After discussion, a motion was made by Mrs. Gauthier, supported by Mrs. Demarest and carried unanimously to include the balance remaining of \$1,000 in the 2015 beautification budget in the 2016 beautification budget for a total of \$2,000 to purchase the planters.

## **CHAMBER OF COMMERCE REPORT**

Kori Tossava showed the summer teaser promos for the Discover the West End campaign. She explained this would be on TV and on the radio during the month of October and slideshows would be available on Instagram and on facebook. They would be publicly launching the campaign on Saturday with e-blast. She also reviewed her report and summarized the various Chamber events and meetings.

## 2016 BUDGET RECOMMENDATIONS

Mr. Slown advised the Budget Committee met to prepare the draft budget. Mr. Lampman reviewed the proposed budget for 2016 which included administration, beautification, promotions, façade, and demolition. There was additional discussion related to the revenues and expenses associated with each budget.

A motion was made by Mrs. Giroux, supported by Mr. Aeh and carried unanimously to approve the 2016 proposed budget as presented by Mr. Lampman.
