The Special Meeting of the Ishpeming City Council was held on Thursday, May 12, 2016 in the Ishpeming City Hall Conference Room. Mayor Mike Tonkin called the meeting to order at 9:00 a.m.

Present: Mayor Mike Tonkin, Council Members Claudia Demarest, Joseph Juidici, and Mike Tall (4). Absent: Councilman Justin Koski (1). Also present were City Manager Mark Slown and City Attorney Bonnie Hoff.

AGENDA COMMENT - There was none.

# GOAL SETTING WORKSHOP AND CAPITAL PROJECTS DISCUSSION

Mr. Slown advised Jesse Shirtz, Library Director, was unable to attend due to a prior commitment.

Ed Anderson was pleased with all the improvements made to the Fire Hall and would continue to address the needs of the facility; a replacement plan for the fire truck would need to be created in the near future, especially with the length of time needed to secure financing, prepare truck configurations, and building of the apparatus could be an 18 month process; and he would continue to apply for FEMA AFG grants.

Dan Willey stated their number one goal was to maintain the current level of service to the public, and maintain the level of staffing, pay, and benefits; continue to enforce the ordinances through the Code Enforcement Officer/Rental Inspector; continue contributions to UPSET; and continue to budget for one police car per year.

Jon Kangas stated goals for 2017 would be to complete the first year of construction for the USDA RD water system improvement project; complete assessment of sanitary and storm sewer systems utilizing the SAW grant; create a Capital Improvement Plan for all departments; and continue working towards creation of an Equipment Fund because equipment was being kept long past its useful life.

Jim Lampman and Kaitlyn Feldbauer discussed goals of the Finance Department, including records retention; exploring bank drafts for utility customers; arranging a secure email, continuing regular computer and server upgrades, window replacements at City Hall, research new general ledger software, as well as, a fleet management software; and thanked Council for authorizing staff to hire a Deputy Treasurer. Council commended Mr. Lampman for all his work on the budget.

Councilwoman Claudia Demarest thanked all the department heads for working together to accomplish goals and thanked the City Attorney for all her efforts and hard work.
