A motion was made by Councilman Koski, supported by Councilwoman Demarest and carried unanimously to approve the Final Payment Request for the Malton Road Non-Motorized Trail project in the amount of \$13,258.42.

A motion was made by Councilman Juidici, supported by Councilman Koski and carried unanimously to designate City Attorney Bonnie Hoff to represent the City at the Marquette County Solid Waste Management Authority meeting on November 30th.

APPROVE SAW GRANT AGREEMENT

Mark Stoor, GEI Consultants, briefly reviewed the specifics of the SAW Grant Agreement.

A motion was made by Councilwoman Demarest, supported by Councilman Koski and carried unanimously to approve the SAW Grant Agreement as presented and authorize the City Manager to sign.
