# 5-YEAR RECREATION PLAN

Every 5 years communities throughout Michigan update their recreation plans to ensure qualification for annual Michigan Department of Natural Resources (MDNR) funding opportunities.

The 5-year recreation plan must adhere to a format defined by the MDNR and outline priority goals, objectives, and projects with the potential to be completed within the 5-year window and beyond.

This document synthesizes data on natural resources, community demographics, existing recreation assets, operational management, citizen input, and community partnerships to generate an allinclusive map for recreation in the community. It describes community values, highlights common goals and objectives, and outlines strategies to achieve these goals.

Looking beyond the 5-year window, this document will serve as a road map for future endeavors improving parks for decades to come. The 2024-2028 Recreation Plan will assist city officials in determining priority projects to nurture an already expansive parks system. It will outline strategies for making parks accessible to all and provide park designs that allow future generations to grow and prosper within.

The National Parks and Recreation Association 2022 Agency Performance Review summarizes what many of us, as Michiganders have realized: "Two years into the coronavirus (COVID-19) pandemic, one thing is clear: parks and recreation is essential." Park visitation increased dramatically during the pandemic, with the promise of access to fresh air and room to run, play, and gather. Park and recreation resources offered within the City of Ishpeming provided residents with the opportunity to pursue the recreation or leisure activity of their choosing (see page 33 Community Survey Results). The parks and trails within the city continue to offer rewarding recreation opportunities while promoting a love for one's community, as well as better physical and mental health. The priorities outlined in this plan will provide increased access to recreational amenities while ensuring there are a variety of opportunities for current and future generations.

Crunching the numbers, the parks and recreation industry is an avenue for community development and growth as well. As noted in a June 2023 speech by Lieutenant Governor Garlin Gilchrist II, "The outdoor recreation sector was worth \$10.8 billion to the state's economy in 2021, providing more than 100,000 direct jobs." The City of Ishpeming already hosts a variety of recreation oriented events, services, and shops, but the potential for additional job opportunities and community development is extensive. By promoting the spectacular natural resources this city has to offer and generating a plan for sustainable recreation design, the promise of a truly resilient community can be realized.

#### Introduction

The City of Ishpeming is a 9.38 square mile parcel of land located in the central portion of Marquette County, within the Marquette Iron Range of the Upper Peninsula of Michigan. It is located adjacent to the west of the City of Negaunee, and about 14 miles west of the City of Marquette.

# CITY OF ISHPEMING

The City of Ishpeming is a mining town with an extensive history of recreation. Known as the "birthplace for organized skiing," one of the nation's first ski clubs was formed in Ishpeming in 1887. Since then the city has produced many famous ski jumpers, practicing on its renowned Suicide Hill. The National Ski Association was formed in Ishpeming in 1904 and the city hosts the National Ski Hall of Fame.

While the community is inseparable from its history of mining on the Iron Range, its distinction as a skiing destination is also deeply ingrained in community culture. The city continues to host Northern Michigan University ski competitions as well as the Junior National Qualifier and annual ski jumping tournament. In more recent history, the city has embraced many other forms of recreation most notably, mountain biking. It has the potential for a tremendous future in recreation with its unique combination of rugged terrain, rich natural resources, and four seasons of varied activities.

The Iron Range is geographically isolated and largely undeveloped wilderness. Most local development occurred due to the wealth underground. The early mining activities lead to the establishment of numerous operational mines within the city limits. The city's homes and businesses literally grew up around the mines. Some of these historic sites have been preserved or are being preserved for future generations to learn about the early life of miners and their families. Today, there are no active mines within the city's corporate limits; however, the Tilden Mine (Iron) is located south of the city in Tilden Township and the Eagle Mine (Copper and Nickel) is located north of the city in Powell Township. Mining still has a significant impact on the city's economy, but not as much as it once did.

In recent decades, recreation and tourism have become a key economic driver within the city. The service and retail trade sectors benefit from money spent by visitors in the area. Agritourism is also making headway within the community with the establishment of Partridge Creek Farm and other local farms. Partridge Creek Farm hosts a successful farm to school program, introducing students to the practice of growing your own food and eating healthier. Ishpeming's future is bright as the city continues to create and sustain a vibrant community that preserves and appreciates its amazing history and abundant natural resources.




Understanding the composition of the population by age will help leaders plan for the types of recreation and facilities that will maximize opportunity for as many residents as possible. In the pie charts shown below, the City of Ishpeming's age demographics are unique in Michigan's Upper Peninsula, illustrating a slight increase in 0-25 year olds. This shift affirms the draw the community provides to young families through hosting affordable housing options, employment and education opportunities, and an abundance of recreational access.


To ensure aging populations and younger generations continue to have access to recreation opportunities the city must continue to develop accessible facilities that can be enjoyed year round.








## **AGE** | 2023

#### City of Ishpeming Budget + Spending

In recent years the city has dedicated an average of \$443,872 annually for parks and recreation operations, maintenance, and capital investment. Figures fluctuated with the influx of grant funds to complete capital improvement and new park construction endeavors. This plan will serve as a first step toward meeting requirements to apply for MDNR grants. By augmenting existing budgets with grant and other outside funding sources the city will have the ability to provide needed improvements and upgrades.






#### **Targets for Capital Expenditures**




#### **Sources of Operating Expenditures**




#### Revenues as a Percentage of Operating Expenditures


#### PEOPLE + FUNDING

#### **ORGANIZATIONAL STRUCTURE**

Under 1917 Public Act 156, the City of Ishpeming has appointed a Parks and Recreation Commission. The Parks and Recreation Commission is a 9-person advisory group which includes representatives from Ishpeming City Council, Ishpeming High School, and other community members. The Commission meets on a regular basis to formulate initiatives for the city's recreational programs and park system, to provide oversight for these areas, and to review and recommend changes to this plan. In addition, we share all our plans with our neighbors in the City of Negaunee, Ishpeming Township, and Negaunee Township. In 2007, the City of Ishpeming and City of Negaunee created a shared use plan for about 300 acres north of Teal Lake and within the city limits of Negaunee. Presently this parcel of land is used for cross country ski trails, hiking trails, and as a nature preserve.

Other City organizations that have a significant role in Parks and Recreation include the Department of Public Works, Police Department, Zoning Board of Appeals, Downtown Development Authority, Neighborhood Improvement Committee, Cemetery Board, and Library Board.


The city currently employs approximately 40 full-time equivalent employees. Departments include City Hall, Carnegie Public Library, 24/7 Police Department, Public Works Department, and a Volunteer Fire Department.

#### **VOLUNTEERS + PARTNERSHIPS**

#### **COMMUNITY VOLUNTEER ORGANIZATIONS**

Volunteers are critical for recreational programs in the city. Ishpeming hosts numerous recreational events supported by volunteers for: mountain biking, cross-country skiing, basketball, and running. League sports, such as little league teams and the American Legion baseball team, enjoy the support of dedicated volunteers.

The City has had a long and successful relationship with community and school organizations. Community organizations supporting recreation include the Downtown Development Authority (ODA), the Ishpeming Business Association, Kiwanis, the Ishpeming Ski Club and various organizations that support recreational activities and youth sports. Ishpeming schools athletic department, booster club, coaches, officials, and athletes are key players in the continued development of

recreational facilities within the city. The city receives support from corporate and individual donations to promote recreational activities and projects as well. Examples include: The development of mountain biking trails within and around the city in partnership with the Range Area Mountain Bike Association, the Iron Ore Heritage Trail Association with development of a multi-use trail system and associated amenities, and the Moose Country Snowmobile Club that maintains the trails throughout the city.

# THE NATURAL ENVIRONMENT LANDSCAPE TYPOLOGIES

The natural features that make up the City of Ishpeming's landscape are defined by rugged terrain and inland lakes. Each landscape hosts its own list of potential recreational opportunities.

The city's landscape can be broken into a series of categories, known as landscape typologies. These include virgin growth forest, deciduous forest, woody wetlands, maintained turf, mixed forest, inland lakes, and hardscape.

The layers of geology, soils, topography, hydrology and existing development are analyzed in the pages that follow. Finding the right balance of development and preservation of natural resources within a community is key to maintaining a long lasting beautiful place for generations to explore and appreciate.

#### **GEOLOGY + SOILS**

Geology and soils provide the foundation for all forms of life and its related activities. Generating an understanding of these baseline layers is critical to developing a well rounded and feasible vision for future development and preservation measures.


Much of the landscape within the city was deposited by glaciers thousands of years ago. As the ice sheet retreated, it left behind a topography of lakes, valleys, hills, and streams. Throughout the city ancient bedrock outcrops were left exposed by the glaciers. Early prospectors soon discovered vast deposits of iron ore. Miners soon followed and Ishpeming became a city built in the heart of the Marquette Iron Range.

The City of Ishpeming has a developed core featuring hardscaped surfaces with natural surface trails weaving throughout. Beyond it's urban center the original landscape typologies are more apparent with a mix of inland lakes, woody wetlands, deciduous and mixed forests, and pockets of herbaceous landcover. The wetland areas feature peaty soils high in organic matter. They serve as nature's sponge soaking up harmful chemicals and pollutants and reducing erosion by slowing the rate of runoff. As illustrated in the diagram above, they improve water quality by filtering and recharging groundwater reservoirs. They also provide abundant habitat for wildlife. It is necessary to preserve these natural filters as much as possible so we can continue to source clean drinking water and keep our waterbodies free from contaminants.

Four main soil orders are present within the city. They include: **Entisols** are typically sandy soils near rocky outcrops or along water bodies. **Histosols** support peatland vegetation and make up a large portion of the county's soil surface. These soils are often within wetlands and serve as large carbon sinks. Although tough to develop on they are a crucial resource in the capture of runoff and filtering of pollutants. **Inceptisols** are typically found on forest floors and contain glacial till with large boulders interspersed. **Spodosols** are also present. These soils are acidic and not very fertile but support forests.<sup>2</sup>




The terrain within the City of Ishpeming is varied with many steep sections and rocky outcrops. Jasper Knob, southeast of downtown, is the world's largest gemstone of jaspilite made up of fine bands of jasper (quartz) and hematite. Brasswire hill was the site of ski jumping tournaments in 1901, taking advantage of the steep terrain. Today, local clubs flock to this landscape for a variety of recreational activities. Mountain biking, cross country skiing, snowshoeing, hiking and motor sports trails crisscross the community. The city recognizes its unique asset in its topography and hosts a multitude of sporting events and races boosting the economy and bringing people to local shops and restaurants.

Exposed bedrock and rolling hills define much of the city's trails as perfectly showcased within Al Quaal's ski trails and the Range Area Mountain Bike Association's (RAMBA) trail network. The paved Iron Ore Heritage Trail runs through the center of the city providing a smoothly graded accessible for trail connecting multiple communities and amenities.

The NRPA 2022 data revealed an average of 3 miles of trail for communities with populations less than 20,000.3 Ishpeming has significantly more miles of trails for its rather small population feeding into the greater region's recreation economy and network. The region has established itself as a premier destination for recreation.

#### **TOPOGRAPHY**



#### WILDLIFE

The Information for Planning and Consultation site hosted by the U.S. Fish and Wildlife Service notes the potential existence of several threatened and endangered species within the Upper Peninsula. There are wetlands and forested areas within the city that provide habitat for a variety of wildlife. Whitetail deer and the occasional bear, moose, or wolf are some of the larger mammals found in the city. A variety of smaller mammals, birds, reptiles, amphibians and insect species also live within the city. Measures taken to preserve habitat and accommodate these species are critical to maintaining their existence. It is critical communities consider both these threatened and endangered species as well as more common animals when planning for development.






### STANDARDS FOR RECREATION

The National Recreation and Park Association (NRPA) has developed a scale to help measure an existing recreation system's park facilities and provide a baseline standard for equitable park access within a community.

A typical park and recreation system offers one park for every 2,323 residents served, with 10.4 acres of parkland per 1,000 residents. Due to its lower density population Michigan's Upper Peninsula trends toward having a higher acreage of parkland per resident. Here is a chart illustrating the different open space typologies defined by NRPA and the desired minimum amount of park space per community.







# **CITY OF ISHPEMING PARKS**

**AL QUAAL** 460 ACRES

This regional recreation site is located in the northern portion of the City, along Popular Street. It is the largest single recreation area within the City's corporate limit. The land that currently makes up this recreational area was leased by the City in 1939 and purchased in 1999. Al Quaal is also known as the Winter Sports Area. Primary winter activities include cross-country skiing, snowshoeing, sledding, and snow biking. This area is used for high school, college, regional, and Olympic level cross-country ski events. It is an FIS certified and homologated cross country ski stadium.

It has hosted numerous cross-country ski events, including: Michigan High School State Championships, Masters Cross-country Ski Championship, Annual Noquemanon Ski Marathon (regional event), Central Collegiate Midwest Regionals and Conference Championships, Midwest Junior Olympic Qualifying Races, Midwest Junior Olympic Combined Nordic Qualifying Races, U.S. Super Tour

The site is used year round, with tennis, basketball, baseball, horseshoes, volleyball, mountain biking, hiking, swimming picnicking, boating, and fishing, occurring in the summer months and skiing, tobogganing, ice fishing, snowmobiling, and snowbiking occurring in winter months. Al Quaal has also hosted the World Championship Snow Bike Race. Facilities at this site include:

#### **Suicide Ski Center**

This ski center is on Suicide Bowl road south of M-28. The site is owned by CCI and leased to the Ishpeming Ski Club. The site hosts a 90 meter ski jump and cross country ski trails.

#### **Iron Ore Heritage Trail**

This **Regional Park** runs through the City of Ishpeming on its 47 mile journey through the northern U.P. It is a destination for all those who recreate in Michigan's upper peninsula creating connections to communities and parks alike. The entire trail is open to hikers and mountain bikers.

#### **River Rock Lanes**

This privately owned facility offers 16 bowling lanes and 6 billiards tables and is located at 1011 North Road in Ishpeming.

#### St. Johns Church

This privately owned facility offers an indoor gymnasium as is located on South Pine Street in Ishpeming.

#### 906 Cross Fit

This privately owned facility offers an indoor strength and fitness center and is located on Lakeshore Drive in Ishpeming.

#### **Cross Bridge Church**

This privately owned facility offers an indoor gymnasium and is located on Third Street in Ishpeming.

#### **Heritage Hills**

This privately owned facility offers a riding stable and horse trails on Malton Road in Ishpeming.

#### **Wawonowin Country Club**

This privately owned facility offers an 18 hole golf course on Co rd 478 in Champion.

#### St. Joseph's Church

This privately owned facility offers an indoor gymnasium as is located on Prairie Ave. in Ishpeming.

#### **Strength and Fitness**

This privately owned facility offers an indoor strength and fitness center and is located on South Main Street in Ishpeming.

# Ishpeming Township Parks Ishpeming Township Park

This seven acre park hosts a softball diamond, little league diamond, tennis courts, pavilion, tot lot, restrooms, concessions, playground, horseshoe court, shuffleboard, volleyball court, basketball court, picnic table and grills.

# City of Negaunee Parks Iron Town Field

This **Neighborhood Park** is located on Prince Street east of Camelot Drive. It is owned by the Cleveland Cliffs, Inc. (CCI) and leased to the City. The site includes a baseball field, concession stand, rest room and storage building.

#### **Miners Park**

This **Community Park** is located on the north side of Hwy 41 between Maas and Maple Streets. It hosts the largest play structure in the community, a picnic pavilion that is frequently rented, illuminated basketball courts, horseshoe courts, a volleyball court, historical marker and rest rooms. Several parents have expressed the need for a fence as the playground is adjacent to Hwy 41.

#### **Lincoln Street Park**

This **Mini Park** is located east of Healy Street and north of Lincoln Street. It is owned by the City and has a basketball court and a picnic table.

#### **Teal Lake Beach**

This **Community Park** is located on the Eastern shore of Teal Lake along Croix Street. The City plans to extend the current storm water culverts that run to the beach into the water and rehab the existing timber retaining wall. Many survey respondents commented on water quality issues and excessive goose poop at this site. The site is owned by the City and features several picnic tables and a swimming area.

#### **Teal Lake Boat Launch**

Teal Lake Boat Launch is a facet of the Teal Lake Beach Park. The facility was installed in 1995 with partial funding from a DNR Trust Fund Grant. The site includes a paved boat launch and accessible fishing dock.

#### **Breitung Park**

This **Neighborhood Park** is located on Pioneer Ave. near the fire station in downtown Negaunee. It is owned by the City and contains a band shell with grassy area and benches.

#### **Veteran's Park**

This **Mini Park** is located in front of the City Hall in Downtown Negaunee. The park has benches, a concrete pathway, a fountain, and a memorial.

#### **Copper St/Partridge Creek Park**

This **Mini Park** is located on the corner of Copper and Division Streets. It hosts a basketball court and grassy area.

#### **Ann Street Park**

This **Mini Park** is located on Ann Street in downtown Negaunee. It hosts a basketball court, sand volleyball, and swing set.

#### **Bartle Park**

This **Mini Park** is located at the corner of Cyr and Lombard Streets. The park features an open grassy area with a gazebo.

#### **Sunset Drive Park**

This **Neighborhood Park** is located on Sunset Drive in the Northeast corner of the City. It hosts a basketball court, grassy field, playground equipment, and picnic area.

#### **Negaunee Ice Arena**

This **Community Park** is located on Rail Street, south of downtown Negaunee. Negaunee features a full sized arena, new locker rooms and rest rooms as of 2021, a lobby, kitchen, concession area, two offices, meeting room and large parking lot.

#### **Buffalo Road Park**

This **Neighborhood Park** is on the southern edge of the City's property at New Buffalo Road. It is owned by CCI and leased to the City. It contains a swing set, basketball court, and picnic area/table.

#### **Chiri Park**

This **Mini Park** is located at the corner of Iron and Silver Street in Downtown Negaunee. It hosts a grassy area with a bench.

#### **Old Town Recreation Area**

This **Regional Park** serves as the community gateway to the Iron Ore Heritage Trail. It hosts a trailhead to the RAMBA mountain biking trail network, a volunteer built disk golf course, and several interpretive stops showcasing the rich history of the region.

#### **Community Play Field**

The Community Play Field is a 5 ½ acre park that is located. The park is owned by CCI and leased to the schools. The park includes an 1,800 person capacity stadium, track, practice fields, rest rooms, lockers, weight lifting room, and concession building. The facility also has an adjacent wrestling and weight-lifting room, lavatory facilities and locker room. The site received an upgrade with the construction of a year round indoor recreation facility.

#### **LaCombe Field**

This **Community Park** is located on Baldwin Street between Water Street and Mitchell Avenue. It features a lighted softball field, batting cages, press box, rest room and storage facility, and an open area used for football/soccer practice. New, high school student built dugouts and an accessible sidewalk are currently proposed improvements for the site. It is owned by (CCI) and leased to the City.

#### **Ericson Parkway**

This **Mini Park** is located between Iron and Jackson Streets It is owned by CCI and leased to the City. It features a winding concrete path with picnic table.

#### **Negaunee Middle School**

The Middle School is located on Case Street Between Pioneer Street and Teal Lake Avenue. It is owned by the school district. The school has a gym, outdoor basketball court, and hard surface play area.

#### **Negaunee High School**

The High School is located on Arch Street. It hosts a 50x75' indoor pool, auditorium, 75x42' gym, and 8 outdoor tennis courts.

#### **Negaunee Luge**

The luge is located on Lucy Hill at 230 E County Road. The property is owned by CCI and leased from the City. It includes warming shacks, a maintenance building, starting house, equipment rental and a parking lot.

#### **Lakeview Elementary**

This school is located on Teal Lake Avenue. It is owned by the school district.

The school features playground equipment, 2 tennis courts, 1 basketball court, and open field, and a gym.

#### **Bernie Rivers Memorial Field**

This **Community Park** is located on Prince Street, east of Vine Street. It contains a baseball field, lighted horseshoe courts, a basketball court, playground, portable rest room, pavilion, concessions and storage building. It is owned by CCI and leased to the City.

#### **Jackson Mine Park + Senior Center Park**

This **Community Park** is located on Tobin Street in downtown Negaunee. It is owned by the City and part of the larger Old Town recreation area. Recent updates include lighting along the Iron Ore Heritage Trail to Ishpeming, a new pavilion with rest rooms, a new parking area and a soon to be new playground.

#### **Richmond Township Parks**

#### **Richmond Township Park**

This park hosts a horseshoe court, basketball court, tennis courts, baseball field, playground, picnic area, pavilion and restrooms.

## Tilden Township Parks

#### **Recreation Complex**

This six acre site with tennis courts, baseball field, horseshoe courts, basketball court, playground area, pit toilets, parking, picnic area, and pavilion.

#### Sands Township Parks

#### **Blueberry Ridge**

This DNR owned trail system is utilized year-round with groomed ski trails, mountain biking, hiking and foraging.

#### **Marquette County Fairgrounds**

This 60-acre site hosts an exhibition building, American Legion building, 4-H building, two cattle sow rings, a poultry and small animal building, a large livestock building, an office building, a barrier free restroom/utility building, two storage structures, parking, outdoor speakers, 1/2 mile race track, mud drag strip, paved go-cart track, large carnival area, outside horse stall, two outdoor pavilions, and portable bleachers.



#### **TRAILS**

Trails for both motorized and silent sport users weave throughout the cityscape connecting to adjacent

communities and wilderness. Trails within and around Ishpeming are a major draw for both residents and visitors and are constantly receiving updates, additions and reroutes. The map to the right captures the current nonmotorized trails within the city and the map on the following page features the DNR layer of ORV and Snowmobile trails.

As a vital part of the recreation scene within the City of Ishpeming it is imperative the city prioritize the continued improvement and sustainable development of trails for all types of users.







# 6

## **COMMENTS + ISSUE SCOPING**

A parks and recreation survey was launched in September of 2022. The survey was shared via multiple methods including print outs around the city, paper copies stationed at several community locales and online. 455 completed surveys were received.

The feedback garnered was extremely informative and helped in generating recreation values, goals and priority improvements for the community. The pie charts on the right illustrate the age distribution of survey participants and the county in general. A relatively diverse mix of age groups were captured in the surveys submitted and nearly all of the responses came from nearby and local year-round residents.

At the public hearing two comments were received, one noting an appreciation for additional improvements to be made at Al Quaal and the

desire to see additional recreation programming as well. Each of these concepts are presented as

priorities in the action plan as well as the other speaker's comment verifying the desire for the community to apply for a grant to improve the tennis courts.

The colorful bubbles within this chapter feature written responses received.

They highlight specific reactions community members had





## **SURVEY RESULTS**

Survey participants were asked to list the recreational activities they participated in within the past two years. Top ranked activities included walking/hiking, biking, sledding, skiing/ snowshoeing, and playing tennis. With many miles of hard surface and mountain bike trails winding throughout the community it was not surprising this was a frequent mention. The number of people noting sledding and tennis as recreation activities was not expected. Many of the responses to the next questions in the survey, including what one would like to change regarding recreation within the community featured a request for the sledding hill at Al Quaal to reopen and the tennis courts to be updated. The desire of respondents to see improvements and more access to these sites indicates two strong candidates for future action items.

## **SURVEY RESULTS**

In an effort to develop a sense if site use, respondents were asked how often they visited each park and if they attended community events. Al Quaal received the greatest frequency of visitors with the trails, Teal Lake, special events in the park, and the tubing hill serving as the key attractions. As the only regional park within the system, Al Quaal serves not only as a daily site for recreation and play but a destination for events.

When asked "What special events have you participated in?" the most frequently visited events included Festival of Treasures, 4th of July, or Labor Day festivities as well as Italian Fest and the Christmas parade, sleigh rides and Santa visits. The other community events mentioned focused on a specific user group and do attract large audiences, but not a vast majority of the general public.

Participants were then asked two key questions that helped define parks and recreation goals and priority projects for the community moving forward. When asked "What do you VALUE about the City of Ishpeming's recreation opportunities?" respondent's most frequently mentioned recreation facilities including trails, Al Quaal, and tennis courts. Ease of access and quality of opportunities available were other frequent mentions. Community values generated from these responses are featured on the following page.

## **VALUES, GOALS + OBJECTIVES**

#### STATEWIDE COMPREHENSIVE OUTDOOR RECREATION PLAN

Michigan's Statewide Outdoor Recreation Plan (SCORP) serves as the backbone for recreation planning within the state. Every five years new surveys are administered, sites studied and outdoor recreation habits mapped. Through developing a clear understanding of how people recreate within Michigan we can help define how to provide additional access and amenities for those utilizing the parks within our communities.

The main objectives outlined in the current SCORP plan:

- Foster stewardship and conservation
- · Improve collaboration between stakeholders
- · Raise awareness of outdoor recreation opportunities
- · Improve recreational access for all
- Provide quality experiences
- Enhance health benefits
- Enhance prosperity via supporting economic prosperity, talent retention and high quality of life

#### **RECREATION TRENDS**

Nationally, many of the more traditional recreation activities, such as camping and fishing, have seen a slight decrease while nature based and backcountry activities are on the rise. Some of these trending activities include:

- Hiking
- Cross-country skiing
- Backpacking
  - BMX/Mountain biking
- Kayaking
- · Stand-up Paddling

Many passive recreation activities are also very popular, as noted in the SCORP surveys including relaxing, walking, picnicking, and unstructured play.


Community members were then asked what they would like to see change regarding recreation within the City of Ishpeming. A summary of the proposed changes is featured on the last two pages of this chapter. Combining these perspectives of community recreation values with desired improvements allowed the planning team to formulate a series of parks and recreation goals for the City of Ishpeming. These include:

Goal 1: Continue to maintain a diverse pallet of recreation opportunities while better utilizing existing park properties.

Goal 2: Create park spaces, events and signage that are easy to located, accessible for all, and reflect a sense of community.

Goal 3: Update well-loved facilities that are outdated or have fallen into disrepair.

The next step was to generate a series of objectives and action items that would help guide the community through the five year planning window and beyond. The following page features a diagram of the City of Ishpeming's recreation values, goals and objectives illustrating the cyclical nature of this process.



# **ACTION PLAN** PRIORITY PROJECTS

The City of Ishpeming has prepared plans for and completed several park improvement projects. The Cities of Ishpeming and Negaunee were awarded a joint grant to install accessible kayak launches at either end of Teal Lake. An outdoor skating rink, recently installed, has proven to be a well-loved community improvement. Brasswire Campground, is a new rustic campground located along Malton Road. Additional future planned community improvements include a future dog park, skate park/pump track, and an outdoor classroom/band stand area.

This Action Plan on the following pages attempts to channel the many ideas provided via community input, recreation board and staff feedback and develop a list of park and recreation improvements IMPROVEMENTS within the coming years. By no means is this a comprehensive list as interests, demographics, and the environment are constantly evolving. The City will continue to revisit its recreation plan within the future and amend this list as needed.

## GOAL #1

Continue to maintain a diverse palette of recreation opportunities while better utilizing existing park properties.

#### TRAILS

- Identify and develop plans for connecting trails in key locations.; this includes creating neighborhood trail/ bikeway connections to the Iron Ore Heritage Trail.
- Ensure a variety of trail types and designs for all ability levels are available within a reasonable distance from all city neighborhoods.
- Provide skill building areas for trail users; including kid, family friendly, and multi-generational trail opportunities.
- Prioritize maintaining existing trails and protecting adjacent natural resources over developing new trails.

## NEW

- Create a park within the downtown core that provides a new form of recreation access serving younger and older generations alike; this could include a skate park or pump track, updated playground and seating/gathering space.
- Create an outdoor classroom/amphitheater space at Al Quaal to function as a community event space and accessible classroom for the schools and community programs/clubs to utilize.
- Consider adding recreation improvements to the old landfill site; these could include dog off leash trails, walking trails, or beginner level bike and ski trails.
- Add more winter recreation opportunities wherever possible including additional skating rinks or trails, ski and snowshoe trails and snowmobile trails/trailheads. When the opportunity presents itself consider electrifying trailheads and corridors to support the use of electric recreation equipment.

## **GOAL** #2

Create park spaces, events and signage that are easy to locate, accessible for all, and reflect a sense of community.

#### TRAILS

- Identify any user or traffic conflicts along existing trail corridors and correct them.
- Provide additional trailheads and parking if needed.
- Notify trail users of proper trail etiquette and clearly mark user types allowed on trails.

#### COMPREHENSIVE SIGNAGE AND MAPPING PLAN

Develop a signage and mapping design plan **MAINTENANCE** that creates a cohesive look throughout the community. Showcase historic nodes as well as park regions within the greater community. Highlight natural features and interpretive opportunities.

#### AL OUAAL

- Continue to promote Al Quaal as a regional recreation destination. Create a comprehensive park master site plan that features existing park amenities, circulation and condition of features as well as provides an overlay of proposed improvements.
- Re-open the tubing hill and seek funding for alternate methods of operating that require fewer staff members be on site if possible.
- Update existing lodges or build a new community recreation facility.
- Provide universal accessibility updates throughout the park with an accessible pathway system linking the various activity nodes.
- Determine if the exercise loop is well-used and update as needed so the equipment is safe to use and functions properly.
- Update playground equipment and introduce accessible amenities including water bottle filling stations, restrooms and picnic areas.
- Provide improved access to Teal Lake.
- Improve existing ski area.

## GOAL #3

Update well-loved facilities that are outdated or have fallen into disrepair.

#### **TRAILS**

- Complete an assessment of existing trails and identify trails in need of re-routes, decommissioning, or maintenance.
- Identify best management practices for trail design and development and create a template for future trail design/build projects.
- Ensure all enhancement and park improvement projects utilize durable, high-quality materials and minimize the need for continuous maintenance.
- Rehabilitate and redesign tennis facilities including the potential to utilize some courts for both pickleball and tennis.

#### Ethics chairman launches a new bid to expel George Santos after a withering report on his conduct

WASHINGTON — The chairman of the Santos announced he would not seek reelection.

"The evidence uncovered in the Ethics Committee's Investigative Subcommittee investigation is more than sufficient to warrant punishment and the most appropriate punishment, is expulsion," said Rep. Michael Guest, R-Miss.

The Ethics Committee referred its findings to the Justice Department, serving up new evidence that could potentially play into the federal charges against Santos. Lawmakers opted to do their work without going through a lengthy formal process that would be used to make a recommendation to the House on the appropriate form of punishment.

Guest emphasized in his statement that he was filing the expulsion resolution separate from the committee process and was doing so in his personal capacity as a member of the House. Several other members of the Ethics panel have also come out in favor of expulsion now that the investigation is complete.

Expulsion from the House requires a twothirds vote, a high bar. It's the sternest form of punishment available to the House and has occurred just five times in the history of the chamber — three times during the in Atlantic City and the Hamptons and to pay for a Botox treatment at a local

The panel also described Santos as uncooperative with their investigation, declining to voluntarily testify or provide a statement under oath.

The findings by the investigative panel may be the least of Santos' worries. The congressman faces a 23-count federal indictment that alleges he stole the identities of campaign donors and then used their credit cards to make tens of thousands of dollars in unauthorized charges. Federal prosecutors say Santos, who has pleaded not guilty, wired some of the money to his personal bank account and used the rest to pad his campaign coffers.

Santos, who represents parts of Queens and Long Island, is also accused of falsely reporting to the Federal Election Commission that he had loaned his campaign \$500,000 when he actually hadn't given anything and had less than \$8,000 in the bank. The fake loan was an attempt to convince Republican Party officials that he was a serious candidate, worth their financial support, the indictment says.

#### Flu is soaring in seven US states and rising in others, health officials say

NEW YORK — The U.S. flu season is underway, with at least seven states reporting high levels of illnesses and cases rising in other parts of the country, health officials say.

The Centers for Disease Control and Prevention posted new flu data on Friday, showing very high activity last week in Louisiana, and high activity in Alabama, Florida, Georgia, Mississippi, New Mexico and South Carolina. It was also high in the District of Columbia and Puerto Rico, the U.S. territory where health officials declared an influenza epidemic earlier this month.

"We're off to the races," said Dr. William Schaffner, a Vanderbilt University infectious diseases expert



### **Hearing Meeting Minutes**

Council Proceedings January 10, 2024 Ishpeming, Michigan

The regular meeting of the Ishpeming City Council was held on Wednesday, January 10, 2024, in the Ishpeming City Hall Council Chambers. Mayor Jason Chapman called the meeting to order at 6:00 p.m.

#### ROLL CALL

Present: Mayor Jason Chapman, Council Members Lindsay Bean, Elizabeth Firby, Renelle Halverson, and Pat Scanlon (5). Also present was City Manager Craig Cugini and City Attorney Caroline Bridges.

PUBLIC COMMENT – Public comment was offered through Zoom and in person.

Claudia Demarest, 821 Maurice Street, talked about compliance with the City Charter, the Open Meetings Act, and the Freedom of Information Act; the December 6<sup>th</sup> closed session was broadcast over channel 189 which was a violation; questioned why the Parks and Recreation Plan 2024-2028 was not presented to the Parks Commission before the public hearing and adoption of the Plan.

Jeff DeGabriele, no address provided, cited some of the articles in the constitution; questioned the parking of the City Mayor's vehicle on City property; reviewed his past sworn statements submitted for Misconduct in Office; and questioned some of the advice of the City Attorney.

Oscar Forsman, 575 Mather Avenue, read the draft of the 2024-2028 Draft of the Parks and Recreation Plan, he agreed with the current partnerships with the School which encouraged the students to invest in the community; and he very much enjoyed all that Al Quaal had to offer to City residents.

Todd Kauppinen, 409 S. Third Street, advised he has been monitoring water pooling on the other side of the abandon railroad tracks by his house and given the previous history of the sink hole he expressed his concerned with the water in that area; he asked if the City could evaluate the situation.

Raymond Olds, 1169 Ninth Street, stated he had talked to several residents that were upset with tickets issued for the parking ban when there was no snow; and reminded Councilmembers and staff to speak into the microphones so people watching on Channel 189 and You-Tube could hear.

Mike Tonkin, 612 N. Third Street, thanked DPW for plowing the alley behind his residence; questioned the time limits for public comment on the proposed agenda received by Council; and noted Council should receive packets by Friday per the Council Rules.

May Tsupros, Partridge Creek Farm, thank Council and staff for doing a good job. She provided an update on the Partridge Creek Farm development near the High School and further noted some of the food grown at the site would be provided to the school; and the school was planning to start a Healthy Cooking Program. She added Partridge Creek Farm applied for and received approval for a bee hive at the Middle School Garden and also developed a safety program for the bee hive. Partridge Creek Farm looked forward to the continued partnership with the City.

#### APPROVAL OF AGENDA

A motion was made by Councilmember Halverson, seconded by Mayor Chapman and carried unanimously to remove item 6b from the consent agenda for discussion prior to the Monthly Financial Statements and remove from the agenda item 14a First Reading of Proposed Rezoning due to the Planning Commission taking no action and approve the agenda as amended.

A motion was made by Councilmember Scanlon seconded by Councilmember Firby and carried unanimously to approve the consent agenda as amended.

#### 7a. Approval of Disbursements

After some brief discussion, a motion was made by Councilmember Scanlon, seconded by Councilmember Firby and carried unanimously to approve the disbursements as presented.

#### MONTHLY FINANCIAL STATEMENT REPORT

Finance Director Grant Getschow reviewed the unaudited balance sheet including the General Fund, Major and Local Street, Water, Sewer, and Garbage fund for the period ending December 2023.

Councilmember Halverson questioned if the renewal fees for the two marijuana establishments have been paid; staff advised they had been paid for both establishments. She also questioned the budget for the Brasswire Campground.

A motion was made by Councilmember Scanlon, seconded by Councilmember Firby and carried unanimously to approve the unaudited monthly financial statement report as presented.

#### ISHPEMING HIGH SCHOOL STUDENT REPORT ON BLOOD DRIVE

Jaylan Wiley and Jackson Foster, Ishpeming High School Students, reported on the Blood Drive that was held on Thursday December 4<sup>th</sup> noting many community members participated along with several City employees and High School Students. The competition was between Ishpeming and Negaunee and Ishpeming won the competition. They thanked all who donated.

#### PUBLIC HEARING: CITY OF ISHPEMING PARKS AND RECREATION PLAN 2024-2028

There was discussion related to the Parks and Recreation Commission not reviewing and providing a recommendation on the Plan to Council before holding a public hearing and before consideration of a resolution of adoption by Council. Manager Cugini advised there was a very tight timeline for approval of the Plan and for the City to be eligible to apply for Michigan Trust Fund Grants and/or Passport Grants in 2024; the Plan would need to be submitted to the DNR by February 1st. He added the School would like to apply for another recreation grant for the Tennis Courts in 2024 and if the Plan is not approved the grant could not be submitted in the 2024 grant cycle.

Julia Cogger, CUPPAD, advised the 2024-2028 Parks and Recreation Plan is required by the DNR for the City to apply for funding. She reviewed the focus points for the development of the plan; recreation inventory programming; accessibility; and special events held in the city. She noted 450 surveys were received which was a large community input. She reviewed the list of projects in the Plan and advised not all the project would be completed within the 5-year period, however, when applying for grants, the DNR would check if the project was listed in the City's Recreation Plan.

Manager Cugini explained this Recreation Plan was in alignment with the Master Plan; the ad was in the Mining Journal; the draft Plan was on the City's website; and this was the final public hearing before adoption of the Plan.

Mayor Chapman opened the public hearing at 7:15 p.m.

Ann Old, 1169 Ninth Street, questioned if the Plan was adopted would a grant for the Tennis Courts be applied for; Manager Cugini advised the Plan must be adopted to apply for the DNR grant for the Tennis Courts.

Councilmember Bean would have preferred to have a recommendation from the Parks and Recreation Commission; however, adoption of the Plan was necessary to apply for grants.

Mayor Chapman closed the public hearing at 7:18 p.m.

## a. Adopt Resolution #1-2024: Adoption of Parks and Recreation Plan 2024-2028 Mayor Chapman read the Resolution into the record.

A motion was made by Councilmember Scanlon, seconded by Councilmember Bean and carried unanimously to adopted Resolution #1-2024, Adoption of the Parks and Recreation Plan 2024-2028.

#### 2024 CITY HEALTH INSURANCE COVERAGE

Ryan Whitley, 44 North, provided a presentation on the current plan renewal rates and the two other Plans, Blue Care Network HRA and HSA plans, which were reviewed by the Health Insurance Committee. He also provided the renewal rates for the dental and vision coverage.

Manager Cugini gave a brief summary of discussions at the Health Insurance Committee meetings. The Committee, which included members of the AFSCME Chapters and Police Officers Association of Michigan would like to renew with the current plan and continue discussions related to the health savings account for possible future consideration.

A motion was made by Mayor Chapman seconded by Councilmember Bean and carried unanimously to approve the renewal of the current plan with MPEC for health insurance coverage from February 1, 2024 through January 31, 2025.

#### PROPOSED WAGE INCREASE FOR PRECINCT INSPECTORS

City Clerk Cathy Smith reviewed the wages for precinct inspectors at surrounding municipalities. She added providing equitable pay for their dedication in carrying out their duties with integrity and commitment is essential for successful elections and would also help to retain the City's experienced precinct workers and to recruit new workers.

A motion was made by Mayor Chapman, seconded by Councilmember Bean to approve the increase to the Precinct Inspector wages to \$15.00/hour and the Precinct Inspector Chair to \$16.00/hour beginning in 2024. Ayes: Mayor Jason Chapman, Councilmembers Lindsay Bean, Elizabeth Firby, and Pat Scanlon (4). Nays: Councilmember Renelle Halverson (1). Motion passed 4-1.

It was the consensus of Council to have a 5-minute recess at 7:42 p.m. Council returned from recess at 7:47 p.m.

#### ADOPT NEW POLICY #419: APPLYING FOR BOARDS AND COMMISSIONS

Manager Cugini advised this was a required policy towards becoming Redevelop Ready Community certified.

A motion was made by Councilmember Bean, seconded by Councilmember Scanlon and carried unanimously to approve Policy 419, Applying for Boards and Commissions as presented.

#### REVIEW/CONFIRM POLICY 601: COUNCIL RULES OF PROCEDURE POLICY

There was discussion related to the proposed agenda which included the number of public comment items, the length of public comment, and adding Unfinished Business and New Business items.

A motion was made by Councilmember Scanlon, seconded by Mayor Chapman and carried unanimously to have the first Public Comment (5 minutes per person) with the person having the option to speak under public comment or reserve time under an agenda item and the second Public Comment (3 minutes per person) for general comments.

A motion was made by Councilmember Bean, seconded by Councilmember Firby and carried unanimously to add New Business and Unfinished Business to the agenda and if there were late additions to the agenda it would be added at the beginning of the meeting under approval of the agenda. A motion was made by Mayor Chapman, seconded by Councilmember Scanlon and carried unanimously to move the public comment after roll call on the special meeting agendas with a time limit of 4 minutes per person.

#### PLANNING COMMISSION RECOMMENDATION

First Reading of Zoning Ordinance Map Amendment: Rezoning from General Commercial to Deferred Development — This item was removed from the agenda.

## First Reading of Zoning Ordinance Text Amendment: Increase Diversity in Multiple Residential District (RRC requirements)

A motion was made by Councilmember Scanlon, seconded by Councilmember Bean and carried unanimously to approve the text amendment for increasing diversity in Multiple Residential District (RRC requirements) as an emergency reading.

#### DECLARE DPW VEHICLES SURPLUS

1998 Chevy S-10 (2WD)\$1000

2010 Chevy Tahoe (4WD)\$500

2002 Chevy 1500 (4WD)\$500

General Foreman Bill Anderson explained the condition of each vehicles. Manager Cugini advised the Marquette County Solid Waste Management Authority would like to purchase the two trucks (1998 and 2002) for a total of \$1,500 to be used only on the Landfill site.

A motion was made by Councilmember Bean, seconded by Councilmember Halverson and carried unanimously to declare all three vehicles as surplus.

A motion was made by Councilmember Bean, seconded by Councilmember Scanlon and carried unanimously to sell the 1998 Chevy S-10 and 2002 Chevy 1500 to the Marquette County Solid Waste Management Authority for the minimum bids amounts of \$1,000 and \$500, respectively, for a total of \$1,500.

PUBLIC COMMENT – Public comment was offered on zoom and in person.

Claudia Demarest, 821 Maurice Street, questioned why the Parks and Recreation Commission did not have an opportunity to review the draft Recreation Plan as there were quorums at the August and October meetings.

Anne Olds, 1169 Ninth Street, does not like to attend meetings at night so she listens at home, however, it is not the same as attending in person because she misses some of the information discussed; but she attends the Mayor's coffee hours and commended the Mayor for having them.

Raymond Olds, 1169 Ninth Street, was concerned with one of the Precincts being at Birchview School.

Dave Kangas, Mayor of Negaunee, explained with leadership comes decisions, and sometimes hard decisions have to be made, but they are necessary and should always be in the best interest of the City.

#### MAYOR AND COUNCIL REPORTS

Councilmember Bean attended the Planning Commission meeting on Monday and the text amendment to increase diversity in the Multi Residential District which was and RRC requirement was approved; she requested work on the Short-Term Rentals Ordinance continue; and suggested the Planning Commission continue discussions to amend the Marijuana Ordinance to allow additional cannabis licenses in the City.

Councilmember Halverson attended the Housing Commission meeting and reported the Commission was looking into increasing rental rates; their 2024 health care was renewed; and they also discussed window replacements.

Councilmember Firby asked if the ice rink was going to be at the Lake Bancroft Pavilion area for the winter again; and explained she worked during the time that the coffee hours were held and was not able to attend.

Councilmember Scanlon would like to see work done on the tennis courts and would like to pursue grant funding; and he would like to get a closeout report within the next few month with regards to the Brasswire Campground.

Mayor Chapman noted it was National Law Enforcement Appreciation Day and thanked all of the City law enforcement officers; wished everyone a Happy New year; the next coffee hour would be on January 26<sup>th</sup> at 1:00 p.m.; and he was still working with ABC-10 highlighting Ishpeming.

#### MANAGER'S REPORT

Manager Cugini advised the City was not awarded the Neighborhood Enhancement Grant; the winter parking ban was not a winter plowing ban; the fire department was recently awarded a grant; and an application was completed for the Distressed Communities Grant for a new fire truck.

#### **ADJOURNMENT**

At 9:09 p.m., a motion was made by Councilmember Scanlon seconded by Councilmember Firby and carried unanimously to adjourn.


10. Please rank your top priority parks and recreation projects within the City: Scale 1= Highest Priority, 8= Lowest Priority






# Q11 Please select the parks and recreation projects you would like to see within the City of Ishpeming.




## GUIDELINES FOR DESIGNING ADA COMPLIANT AND UNIVERSALLY ACCESSIBLE PARKS

## Michigan DNR Guidelines

- ACCESSIBLE -WALKWAYS WITHIN A SITE minimum 6 foot TRAILS width and slopes under 2%
  - -Multi-use trail 8 feet, with slopes under 2%, wider width so two people can walk side by side or people can pass
  - -REGIONAL TRAIL SYSTEM at least 10 feet wide. with 1-foot buffers on either side, with slopes
  - -Surface Treatment unitary surface (ex. concrete, boardwalk or asphalt, crushed aggregate/screenings that have been "stabilized" or natural soils enhanced with soil stabilizers)
  - -Transitions plates between trail and pedestrian bridges, decks, etc.
  - -INTERSECTIONS contrasting color treatment and textured surface treatments such as brushed concrete at intersections or interpretive stations to cue people who have vision impairments that there is something to pay attention to at that spot
  - -Close to level cross slopes (side to side) and very gentle running slopes, no steep sections, larger (greater than 60"X60") level areas at all turns and intersections
  - -Thoughtfully laid out on the site to maximize the experience with minimal difficulty
  - -AMENITIES All should be accessible including: benches, restrooms (port-a-johns), drinking fountains, etc.



### GUIDELINES FOR DESIGNING ADA COMPLIANT AND UNIVERSALLY ACCESSIBLE PARKS

#### SKIING + SLEDDING HILL

-Accessible route to top (no steps), possibly using a "magic carpet" lift

-Level surface for sled mounting at hill top -If staffed, provide ATV transport or have policy that allows personal ATV use

-Transfer at hill bottom to help transfer down to sled and back up into chair/walker

SPORT COURTS -Routes to both sides of all fields and courts, + FIELDS not just end zones

-Accessible seating spaces both ground level and elevated if risers/bleachers are provided

-Accessible seating spaces scattered throughout all viewing areas and levels with companion seating on both sides of the space

-All lowered service windows at all concession areas

-Wider gate openings into court areas (tennis, bocce, basketball) and skate parks to accommodate wider sports wheelchairs

-Routes to both horseshoe pits and along both sides of the route between pits

-Level routes onto bocce courts with sitting benches at both ends

### GUIDELINES FOR DESIGNING ADA COMPLIANT AND UNIVERSALLY ACCESSIBLE PARKS

- PLAYGROUNDS -Has both ramp and transfer access to all play components
  - -Ramps to every "getting on spot" or "sit/stand & do it spot" of every play component
  - -Transfer system from the ground up to the main deck located near the exits of slides and climbers furthest from the ramp onto the structure
  - -Only unitary safety surface such as poured-inplace or rubber tiles NOT any loose fill materials likes shredded rubber, wood chips, engineered wood fiber, or any other non-unitary surface material
  - -On deck transfer platform at the entry point of every slide
  - -On deck transfer platform with one open transfer side and one side with transfer steps to every entry/exit point of every climber, so kids climbing up can get down to the deck to move to another component, as they may have left an assistive device at the ground
  - -A good variety of things to manipulate that make noise or music, have high contrast/bright colors, games that two kids can play (to foster social interaction), Braille and sign language panels to teach awareness, easy to operate with just one hand with a whole fist (does not require tight/pinch/grasp/wrist twist to operate)
  - -Different high contrast colors for decks versus transfers so kids with low vision can perceive a change in level
  - -Play panels are located at heights so they can be used from a seated position or standing




# CITY OF ISHPEMING GUIDELINES FOR DESIGNING ADA COMPLIANT AND UNIVERSALLY ACCESSIBLE PARKS


- RESTROOMS -More than the minimum number of accessible units
  - -Multiple unisex/single user toilet rooms/units so opposite sex care givers can assist; also good for parents of young children of the opposite sex so kids aren't sent alone into the multi-use restroom
  - -Thoughtfully located near areas of activity such as play areas, beaches, fishing piers, etc.
  - -Accessible door pulls and water faucet handles
  - All accessible port-a-johns, again big enough for individual use or care giver/parental assistance.

## AREAS + ELEMENTS

- PICNIC -All tables, grills, fire rings, water pumps, etc. are accessible -All located on accessible routes
  - -Level routes onto pavilions with no changes of level from path to pavilion surface
  - -Wider routes and clear space with firm surface around all elements so someone with mobility limits can easily move around the element (table, grill, etc.)
  - -A variety of table styles, some with clear sitting space on the side, some with extended table tops on the end
  - -Some fixed tables to ensure they remain accessible (not moved off into a grassy or sandy area, etc.)
  - -Clear space all around each element so people can approach and use the grill, fire ring, etc. from the front, back and either side
  - -Grills you can lower/raise the cooking surface with one hand
  - -Raised fire building surfaces so you can place wood without learning too far over from a standing or seated position



- A. Distances referenced here assume the front edge of a chair lines up with the edge of a table top.
- B. Allow a minimum of 36" between seat backs to permit wheelchair access between tables.
- C. Allow a minimum of 24" between seat backs to provide a walkway between tables.
- D. Allow a minimum of 18" between a seat back and a wall or edge to permit access to all seats.
- E. Allow a minimum of 60" between a seat back and a site's entrance to allow for easy egress.
- F. Please refer to ADA guidelines and local codes to determine the number of wheelchair accessible seating spaces needed in a seating group. It is recommended that a minimum of 32" in width be provided to accommodate a wheelchair at a table.
- G. The minimum height and depth clearances necessary to accommodate a wheelchair at a table

Quick reference of minimum requirements for DISABILITIES ACT accessible spaces. The 2010 American with Disabilities (ADA) Act Standards for Accessible Design Guidelines provide a comprehensive resource. https://www.ada. gov/2010ADAstandards\_index.htm

- Clear width is 36" min for most accessible routes
- Surfaces: 1/4" max change, slopes less than 5%, firm and stable
- Head Clearance: 80" high and as wide as the route
- Clear Space: min 30" wide by 48" deep located at element
- Viewing: clear from 32"-51" height
- Maneuvering space: 60"x60" min and level, at entries and places for change of direction
- Transferable height: 17"-19" with transfer supports
- Knee Clearance: 27" high by 30" wide by 25" deep
- Table tops, counters, and rail heights: max 34" high
- Reach range: 48" max height forward and 15" min low side
- Operation: operating mechanism that is operable with one had and does not require tight pinch/grasp/ wrist twist to open

The following page features a closer look at the City of Ishpeming's parks. These sites have been assigned an accessible rating derived from this scale.

The Michigan DNR Rating Chart is as Follows:

- 1 None of the facilities meet accessibility guidelines
- 2 | Some of the facilities meet accessibility guidelines
- 3 | Most of the facilities meet accessibility guidelines
- 4 THE ENTIRE PARK AREAS MEET ACCESSIBILITY GUIDELINES
- 5 | The entire park was developed using universal design principles

The parks were assessed on August 2nd, 2023 with the City of Ishpeming Parks Foreman and Julia Cogger with CUPPAD. Terrence Van Doren of Michigan Municipal Risk Management Authority was in attendance as well to discuss how to bring the city's playgrounds into safety compliance.

In general, nearly all of the sites assessed require ADA striped and signed parking spaces and accessible hard surface routes from parking to the various site amenities. The vast majority of playground features are deemed inaccessible and will need to receive adequate, accessible safety surfacing to bring them into compliance. Other, more simple improvements include relocating garbage receptacles and benches onto accessible surfaces to meet ADA accessibility requirements. The new playground and pavilion at Lake Bancroft Park are the perfect example of a universally accessible site.

## AL QUAAL Accessibility Rating: 2













Al Quaal is an expansive property with a vast array of recreational features. Although restroom and pavilion structures are accessible, the other amenities on site are not. A winding paved park road allows users of all ability levels to access the majority of the park, but no ADA parking spaces are striped and labeled with the international symbol of accessibility at the informal lots along the roadway. The play equipment lacks safety surfacing and is situated in turf areas with no ADA access. The trails are designed for a variety of users in all seasons, but none are equipped with proper grade or surface to accommodate those with mobility issues. Picnic areas, the exercise loop, and disk golf course are all positioned on turf as well, preventing those with mobility issues from accessing them.

The site would benefit immensely from a comprehensive park plan highlighting circulation between, consolidation of, and access to the various amenities the park has to offer. Upgrading existing playground areas, the exercise loop, and disc golf course as well as integrating accessible pathways within the park would be appreciated by all who come to experience this community treasure.









## LAKE BANCROFT PARK ACCESSIBILITY RATING: 3







Lake Bancroft Park is really divided into two separate areas:

1. The waterfront park with a paver walking path, picnic spots and a restroom. The pathway and restroom meet accessibility requirements. The picnic area requires at least one accessible table to be mounted on a hardened, accessible surface with a 3' space around it for maneuvering. The parking area requires a sign with the universal symbol for accessibility and striping of at least one spot. Each of these endeavors could quite reasonably be implemented by the city.





2. The Cliff Shafts Mining Museum parking area featuring the ADA accessible Mining Heritage Pavilion and the new ADA accessible play area. There is also accessible parking and picnic tables, meeting all requirements.

## MARQUETTE STREET PLAYLOT ACCESSIBILITY RATING: 1





The Marquette Street Playlot is a small open space featuring a few swings and a slide with no safety surface. The city realizes the need to update the equipment and add and accessible parking space and pathway.

# BARNUM (7TH ADDITION) PLAYLOT ACCESSIBILITY RATING: 1





The Barnum (7th Addition) Playlot is a small hidden pocket within the city featuring a basketball court and a couple play equipment items. The park is accessed via an alleyway and somewhat hard to find. There are currently no accessible features. The park would benefit from better marking, perhaps a new, accessible function or updates to the existing infrastructure.



# LAKE ANGELINE PLAYLOT ACCESSIBILITY RATING: 1



This playlot features some aged play equipment and picnic area. To meet accessibility requirements it would need to receive updates to the playground equipment, an accessible trail connecting the disparate elements and accessible parking and picnic space.

## BRUCE ASGAARD PARK ACCESSIBILITY RATING: 1





Bruce Asgaard Park is another small, hidden park within the city. Positioned amid the backyards of homes on Wabash and 9th Streets with no entrance signage, the park feels more like an extension of the neighbor's backyard's versus a public park space. The park does not host any accessible features with dated playground equipment and no safety surfacing, a basketball court and grassy area. The park would benefit from a sign at the entrance, updated equipment, accessible parking and pathway and perhaps an all seasons skating rink and multi-use field or updated basketball court.

## SALISBURY PLAYLOT ACCESSIBILITY RATING: 1





This playlot features some aged play equipment. To meet accessibility requirements it would need to receive updates to the playground equipment, an accessible trail connecting the disparate elements and accessible parking and picnic space. With so many aged playlots featuring minimal amenities it was discussed that sites, such as this one could perhaps be re purposed or sold allowing the city to focus its energy and funds on fewer properties.

## JUNIPER STREET PLAYLOT ACCESSIBILITY RATING: 1

Juniper Street Playlot is another little hidden park at the south end of Hickory Street situated along an alleyway. The park features a few items of outdated play equipment without safety surfacing or accessible pathways. It also hosts a basketball court. Accessibility upgrades would need to include adding an accessible play feature with accessible safety surfacing, a hardened access path, and signed and striped accessible parking space and access to the other disparate elements including the basketball court and grill.

## MATHER 'A' BALLFIELD ACCESSIBILITY RATING: 2





Mather 'A' Ballfield has the potential to meet accessibility standards with a few updates. The parking area is paved, but requires at least one striped and signed ADA parking space. The port-a-jon could be moved onto the paving area and replaced with an accessible unit, ensuring there is no lip upon entry and is properly signed with the universal symbol of accessibility. The bleachers once had a compacted gravel path and seating area, but this needs to be top dressed and re compacted.

## HOLMES PLAYLOT ACCESSIBILITY RATING: 1



The Holmes Playlot has a slight increase in elevation from the street to the play area. The addition of an ADA parking space and hardened surface accessible path would need to be made, connecting each of the separate elements. The play structures at this site are of a more recent vintage and one features a transfer platform. With accessible surfacing and pathway, this site could be brought up to accessibility requirements.

## SECOND STREET PLAYLOT ACCESSIBILITY RATING: 1









The Second Street Playlot also features slightly more recent playground structures and a transfer platform. The existing picnic table is also designed to be accessible. As with the other facilities an ADA parking space, accessible safety surfacing and an accessible connector path are needed to bring this park up to ADA standards.

## POWER OF TEN POCKET PARK ACCESSIBILITY RATING: 3





This pocket park was clearly designed to be ADA accessible. The compacted gravel trail, access ramp to the pavilion each meet accessibility standards. The site does require some maintenance as weeds are growing through much of the pathway. Also, a 30x48" accessible surface adjacent to each bench should be provided as well as locating the garbage receptacle on a hardened surface.

## RAMBA TRAILHEAD ACCESSIBILITY RATING: 2









This site features appropriate compacted gravel and paved surfaces for accessibility but require some key upgrades and repositioning of site amenities to meet ADA requirements. The paved Iron Ore Heritage Trail is a perfect example of an accessible recreation corridor. The Port-John is not accessible and would need to be replaced with an accessible unit sited on the accessible surface. An ADA parking space would need to be provided as well as a picnic table and garbage receptacles located with an ADA accessible approach on a hardened surface.

## CITY PLAYGROUND ACCESSIBILITY RATING: 2







City Playground is an expansive site with a wide variety of recreation amenities. The site features a variety of city managed and some school district managed facilities. The parking at the south end of the park does have an adequate number of signed and striped ADA parking spaces. The south end also features a play area in need of accessible paths linking features and accessible safety surfacing. Some of the structures do have a transfer platform. The tennis courts and basketball courts have mowed turf and parking around them, preventing those with mobility issues from spectating or accessing the courts. The restroom at the south end is not accessible. The pavilion could be, but requires an accessible pathway to it.

The north end of the park hosts baseball and little league fields. Port-a-Johns and parking areas situated intermittently along the gravel road that connects the north entrance of the park to the south entrance. The Port-a-Johns are not ADA compliant and no ADA accessible parking spaces are signed or striped. Seating at the fields consists of bleachers stationed on mowed turf, with no hardened surface, at grade seating areas for those with mobility issues.
